# HAPPENINGS AT NORTHROP GRUMMAN

#### Northrop Grumman Corp. (NG)

LOS ANGELES — NG reports second quarter 2006 income from continuing operations of \$442 million, or \$1.26 per share, compared with \$369 million, or \$1.01 per diluted share, for the same period of second quarter. 2006 sales were \$7.6 billion compared with \$7.8 billion in the second of 2005. "We continue to expect double-digit growth in 2006 earnings per share," said Ronald D. Sugar, NG chairman and chief executive officer

SAN DIEGO — In August, John Galisky, a teacher in Lompoc, CA, who has longed to become an astronaut, was given a ride aboard a G-Force One aircraft which will put him through an experience akin to zero gravity. Mr. Galisky will be in San Diego as part of NG's Weightless Flights of Discovery program. The program will give teachers a chance to do experiments and demonstrations in complete weightlessness.

#### **Mission Systems Sector(NGMS)**

LOS ALAMITOS, CA — A system developed by NGMS is providing critical voice communications and real-time video surveillance and imagery to the U.S. Marine Corps and Los Angeles public safety agencies participating in a disaster-response exercise underway at Los Alamitos. The Battlefield Airborne Communications Node (BACN pronounced "bacon") is a forward-deployed airborne communications relay and network centric information server that allows real-time information exchanges among many different, distant military and commercial communications systems.

# **CANDIDATE BIOGRAPHIES**

He worked in the Applied Technology Division for both the Hardness and Survivability, and Fluid & Thermophysics Departments. Darrell retired in 1998 and volunteers for several community organizations including the TopSail Youth Program which provides character-building sail-training for youths not coping well with the demands of society. He Chairs the TRA Archives Committee, and he is President of TRA.

**BOB BEACH:** Bob is a Director-at-Large. He retired in Aug. 1991 after 36+ years of service. He has been active with TRA since his retirement. He was secretary in 1994. Bob is an avid hiker, backpacker, and peak climber and actively works with the Boy Scouts and the Sierra Club. He also volunteers to do income taxes for the AARP Tax Aide Program.

**BUDD COHEN:** Budd retired after serving over 30 years in a series of management positions. He served as Director of ECHO, directed the Forum Colloquia Series, and was Editorial Director of Quest. **ROSE MARIE A. KEIDEL:** Rose Marie earned an AA in General Engineering at LACC. She joined STL in 1961 and left in 1965 for her first baby, then worked at raising five children with Richard Keidel. **REDONDO BEACH** 

The downlink phased array antenna developed by NGST for the Advanced Extremely High Frequency (EHF) military satellite communications payload has completed range tests that confirmed performance predictions. NGST will provide the Advanced EHF payloads to Lockheed Martin, prime contractor for the Advanced EHF system. This downlink will be the first to operate at 20 GHz in space, significantly increasing capacity and connectivity over the legacy Milstar system.

NGST has begun constructing a dedicated facility for systems integration work and low-rate production of high-energy lasers for military weapon systems. A laser power of 100 kW will be demonstrated at the 11,000 sq. ft. Directed Energy Production Facility at the Space Technology Sector's Space Park campus.

In an ongoing demonstration of the technological readiness of the James Webb Space Telescope (JWST), NGST and Ball Aerospace & Technologies successfully completed rigorous tests that proved the primary mirror in this telescope can withstand launch, and function as planned in its space environment. One test subjected the mirror segment to the acoustic noise it will encounter when launched aboard the Ariane 5 launch vehicle. The test setup consisted of gigantic speakers rented from a rock concert acoustics company that produced the 141 decibel blast needed for the test.

NGST has developed Skyguard, a high-power laser system to defend against air-based threats such as short-range ballistic missiles and rockets, artillery and mortars. Like earlier systems developed by NGST, Skyguard is a multimission, soldier operated, compact and transportable laser weapon system designed for field deployment. A single Skyguard system can defend deployed forces, a large military installation, and/or a large civilian population or industrial area. One Skyguard system is capable of generating a protective shield of about 10 kilometers in diameter. It has been developed for the U.S. Army and the Israel Ministry of Defence.

#### **Electronic Systems Sector(NGES)**

▶ ROLLING MEADOWS, Ill — NG has been selected by the Department of Homeland Security (DHS) for Phase III of the Counter-Man Portable Air Defense System (Counter-MANPADS). During this contract for \$55.4 million, NGES will complete production of 12 Guardian missile defensive systems, modification of 11 MD-10 aircraft, and operation of the Guardian systems onboard nine MD-10 cargo aircraft flying in regular commercial service. The Guardian system is a defensive aid utilizing

proven military technology to defend against shoulderfired missiles. Once launched, the missile is detected by the Guardian system which then directs a non-visible, eye-safe laser to the seeker head of the incoming missile disrupting its guidance systems.

#### Information Technology Sector (NGIT)

MCLEAN, VA — The U.S. General Services Administration (GSA) has approved NGIT to provide integrated solutions for Homeland Security Presidential Directive 12 (HSPD-12) implementations. This mandate will create a standard identification credential with a biometric for enhanced authentication for all federal workers. NGIT is now authorized by the GSA to provide products and services related to smart card enrollment and registration, card activation and finalization, card management and production, and systems infrastructure and integration.

#### Integrated Systems Sector(NGIS)

SAN DIEGO, CA — The U.S. Navy has awarded NGIS a \$135.8 million modification to a previously awarded contract for the Fire Scout vertical takeoff and landing tactical unmanned air vehicle (VTUAV) program. A total of nine MQ-8B Navy Fire Scouts are planned. NGIS's Unmanned Systems Development Center in Rancho Bernardo, CA, manages the contract and provides engineering services. The basic airframe is manufactured by Schweizer Aircraft and final work is done at NGIS's Moss Point, Mississippi, facility. Fire Scout will provide warfighters with real-time video imagery and communications capability. It can fly missions of more than eight hours.
