#### **HAPPENINGS AT NORTHROP GRUMMAN**

#### Reported by Frank Warren

#### Northrop Grumman Corp. (NG)

LOS ANGELES, CA — NG has been honored with a top ranking by the Human Rights Campaign (HRC) for its commitment to diversity by ensuring the rights of gay, lesbian, and transgender (GLBT) employees and consumers. NG, which received a 100-percent ranking, was one of 138 companies receiving a top ranking this year.

#### **Space Technology Sector (NGST)**

- ➤ REDONDO BEACH, CA An antenna built by NGST deployed successfully September 16 onboard NASA's Mars Reconnaissance Orbiter (MRO) for an experiment that continues the search for liquid or frozen water in the first few hundreds of feet of Mar's crust. SHARAD's antenna, weighing less than three kilograms (6.6 lbs), deployed to a length of 10 meters (33 feet) to provide the configuration required once the spacecraft reached its circular, two-hour orbit around Mars.
- ➤ REDONDO BEACH, CA Nearly two months of rigorous tests conducted by NGST showed that Milstar terminals operated by the U.S. Army and Air Force can send and receive through the next-generation Advanced Extremely High Frequency Satellite (EHF) military satellite communications system. The company is providing the Advanced EHF payloads to Lockheed Martin, the prime contractor for the Advanced EHF system.
- ➤ SAN DIEGO, CA NGST recently completed the 12th in a series of ongoing flight tests of an enhanced Wideband Networking Waveform (WNW). The enhanced WNW software, hosted on NG-developed software-defined radios, successfully demonstrated key airborne network waveform capabilities. WNW is designed to facilitate interoperability between the services, provide seamless delivery of video, voice and data, support ad hoc formation of scalable networks. The U.S. Department of Defense has specified WNW for the Joint Tactical Radio System (JTRS) program to establish internet protocol-based networking and provide transformational communications for the warfighter.
- ➤ REDONDO BEACH, CA NGST has been certified as meeting Level 5 standards for software development set by the Software Engineering Institute (SEI) for Capability Maturity Model Integration (CMMI(r)), the highest possible rating for benchmarking commercial and defense industry best practices for management and engineering. The recertification by the lead assessor, Norausky Process Solutions, Inc., examined quality processes and standards across the sector, including its programs, engineering, and production and supply chain organizations.

#### **Mission Systems Sector (NGMS)**

- ➤ AURORA, CO NGMS, one of Aurora's largest defense contractors, is preparing to expand its presence there with a 75,000 sq. ft. office building. NGMS develops highly sophisticated hardware and software systems for various U.S. customers in support of homeland security, national defense and intelligence programs.
- ➤ HAMPTON ROADS, VA The U.S. joint Forces Command has selected NGMS to continue providing technology support to the Joint Warfighting Center (JWFC) in Suffolk, VA. The initial two-year \$218 million contract has a potential value of \$686 million over six years, if all options are exercised. The JWFC prepares U.S. armed forces and coalition partners to fight as an integrated "joint force" in current operations and for future contingencies. The program includes conducting realistic, large-scale warfighting exercises for a collection of networked training sites, using computer simulations, modeling, collaborative tools and other technologies that are linked to actual command and control systems.
- ➤ HUNTSVILLE, AL NGMS fire control and launch control equipment software, developed for the U.S. Missile Defense Agency's (MDA) ground-based midcourse defense (GMD) system, successfully performed during MDA's Flight Test 2, where the interceptor successfully tracked and subsequently destroyed the target warhead over the Pacific Ocean. These software systems play a pivotal role in launching the system's ground-based interceptor and orchestrating the overall engagement sequence. The test involved launching a ground-based interceptor from Vandenberg Air Force Base (VAFB) against a missile launched from Kodiak Launch Complex, Alaska.

#### 2007 Benefits Enrollment

Northrop Grumman has notified TRA that they will be mailing our Individualized Benefits Enrollment Kits between October 30 and November 3, 2006. If a retiree decides to make changes to his/her medical plan, the Benefits Center must be notified between November 6 and November 29, 2006. If the choice is to maintain the current plan, no action is required.

And good news for those retirees who are not on the pension plan. An auto-pay feature for their benefit payments will become an option on July 1, 2007.

#### Dean E. Wooldridge

Dr. Dean Everett Wooldridge, who along with Dr. Simon Ramo, founded TRW, died September 20, 2006. He was 93.

Dr. Wooldridge, the "W" in TRW, was an accomplished scientist who made significant contributions to the nation during his long, productive career in both business and academia.

Dr. Wooldridge graduated from high school at the age of 14; received a



master's degree from the University of Oklahoma at age 20; and earned a doctorate from Caltech at age 23. He joined Hughes Aircraft Company with his fellow alumnus, Dr. Simon Ramo.

The pair left Hughes to form the Ramo-Wooldridge Corporation. In 1958, Ramo-Wooldridge merged with its financial backer, Thompson Products, and Thompson Ramo Wooldridge, Inc. was formed. But four years later, at the age of 49, Wooldridge retired and completely divorced himself from aerospace.

James A. Wooldridge said that his father never told him what caused the abrupt change "He was a physicist and an engineer, and suddenly he was president of a multinational company," his son said. "Maybe he got bored." Well-off financially from TRW stock, Wooldridge spent the next 10 years traveling with his wife before delving deeply into educating himself on neurology, his son said. He published two books — *The Machinery of the Brain* and *The Machinery of Life* as a result of these studies.

Wooldridge's wife, Helene Detweiler, died in 2001. In addition to James, of Basking Ridge, N.J., Wooldridge is survived by another son, Dean E. Wooldridge Jr. of Las Vegas; a daughter, Anna Lou Eklof of Bailey, Colo.; and three grandchildren.
